

Mobility Makeover Questionnaire



The National Mobility Equipment Dealers Association (NMEDA) and our sponsors: Fiat Chrysler Automobiles (FCA), American Honda Motor Company, BraunAbility and Vantage Mobility International (VMI) have teamed up to giveaway one wheelchair accessible vehicle with conversions for a veteran with spinal cord injury or disease.

General Selection Process Information

The producers will be selecting participants for a TV special based on the emotional impact of their injury, disability or illness to them, the ability to articulate on camera their personal story, and the cooperation provided to assist producers in filming the participant at home, work, rehab or other production requests.

Initially, the participants will submit a completed questionnaire and a still photo. Once these questionnaires are reviewed, approximately six participants will be elected. Then the producers will conduct a phone or other electronic communication system interview by October 30, 2017. The producers may elect to visit some of the finalists to further assist in the selection process. One participant will be cast for the TV special and in return will receive a wheelchair accessible vehicle or automotive mobility equipment.

Please note that this is not a competition or a contest or part of the Local Heroes program that the National Mobility Equipment Dealers Association and their members have sponsored in the past.

Supply names of doctors and/or rehabilitation facility or specialists.

Legal Information

If selected you will be required to sign a release form giving us permission to use you in the special. The legal release will allow permission to include you in advertising, social media, press releases and promotional materials for 24 months. Friends, family members and co-workers (if any) included in the video will need to sign a release as well.

It is free to be considered for the TV special and no purchase is necessary. Selected participant must live in the United States and be a legal resident. Odds of being selected for the TV special are one in 300.

The selected participant will be responsible for taxes on the wheelchair accessible vehicle and/or the automotive mobility equipment (valued at over \$50,000 MSRP).

The National Mobility Equipment Dealers Association and the sponsors are not responsible for lost, late or damaged entries.
